CLASS TITLE: CONFIDENTIAL ADMINISTRATIVE ASSISTANT

BASIC FUNCTION:

Under minimal supervision, performs a variety of complex confidential clerical and administrative assistant duties in support of management. Responsible for highly confidential clerical duties related to all Interest-Based Bargaining groups. Plans, coordinates and organizes office activities and coordinates flow of communications and information; prepares and maintains a variety of manual and automated records and reports related to assigned activities.

REPORTS TO: Cabinet-level administrator

SUPERVISES: No supervisory responsibilities

REPRESENTATIVE DUTIES:

ESSENTIAL DUTIES:

Perform a variety of complex clerical and administrative assistant duties to relieve the administrator of administrative and clerical detail; plan, coordinate and organize department or site activities and coordinate flow of communications and information to assure smooth and efficient operations; monitor related functions to comply with established laws, rules, regulations, policies and procedures.

Serve in a confidential (non-represented) capacity regarding employer-employee relations. Take meeting minutes, refines and distribute minutes in a timely manner. Revise and update union contracts, produce memorandums of understanding and tentative agreements. Access confidential information that is used to contribute significantly to the development of management positions.

Compile information and prepare and maintain a variety of records, logs and reports related to programs, students, financial activity, budgets, attendance, staff, projects and assigned duties; establish and maintain filing systems; review, revise, verify, proofread and edit a variety of documents; prepare and process student enrollment paperwork and related rosters, records and reports as assigned.

Serve as primary administrative assistant to the assigned administrator; perform public relations and communication services for the administrator; receive, screen and route telephone calls; take, retrieve and relay messages as needed; schedule and arrange appointments, conferences and other events.

Receive visitors, including administrators, staff, parents and the public; provide information or direct to appropriate personnel; exercise independent judgment in resolving a variety of issues; refer difficult issues to the administrator as needed; provide technical information and assistance related to department, site, or County Office operations and related laws, rules, regulations, policies and procedures.

Input a variety of data into an assigned computer system; establish and maintain automated records and files; initiate queries, develop spreadsheets, manipulate data and generate various computerized lists and reports as requested; assure accuracy of input and output data.

Compose, independently or from oral instructions, note or rough draft, a variety of materials such as inter-office communications, forms, letters, memoranda, bulletins, agenda items, labels, fliers, requisitions, handbooks, newsletters, brochures, certificates, contracts and other materials; format materials to meet needs; develop and maintain department or site web pages as assigned.

Collect various monies and fees for assigned office or programs as required; prepare deposits as directed.

Perform a variety of clerical accounting duties in support of department or site; monitor income and expenditures; assure expenditures do not exceed established budget limitations; calculate, prepare and revise accounting and budgetary data; balance and reconcile assigned accounts and budgets; assist with budget development and preparation; maintain various financial and statistical records and files; prepare, process and code purchase orders and invoices as assigned; arrange for billings and payments as directed.

Operate a variety of office equipment including a calculator, copier, fax machine, typewriter, computer and assigned software;

arrange for equipment repairs as necessary.

Communicate with County Office personnel, governmental agencies and various outside organizations to exchange information, request and provide materials, coordinate activities and resolve issues or concerns regarding assigned department or site.

Monitor inventory levels of office and designated County Office supplies; order, receive and maintain appropriate levels of inventory as required.

Receive, open, sort, screen and distribute mail; compose replies independently or from oral direction; prepare and distribute informational packets and bulk mailings.

Perform special projects and prepare various forms and reports on behalf of the assigned administrator; attend to administrative details on special matters as assigned.

Research, compile and verify a variety of data and information; compute statistical information for various reports as necessary; identify and resolve a variety of financial and statistical discrepancies; assure mandated reports are completed and submitted according to established time lines; distribute, collect, process and evaluate a variety of forms and applications related to assigned functions; duplicate and distribute materials as needed; assist with the preparation, processing and maintenance of grant information, records and related materials as assigned.

Coordinate, schedule and attend a variety of meetings, workshops and other events; prepare and send out notices of meetings; compile and prepare agenda items and other required information for meetings, workshops and other events; set up equipment and supplies for meetings and other events as needed; take, transcribe and distribute minutes as directed.

Maintain appointment and activity schedules and calendars; coordinate travel arrangements and hotel reservations as necessary; process reimbursement claims; reserve facilities and equipment for meetings and other events as needed.

Train and provide work direction and guidance to designated clerical personnel as assigned; provide input concerning employee interviews and evaluations as requested; assign clerical staff duties and review work to assure accuracy, completeness and compliance with established guidelines.

Perform related duties as assigned.

ABILITY TO:

Answer telephones and greet the public courteously.

Learn County Office organization, operations, policies and objectives.

Maintain a variety of records, logs and files.
Type or input data at 55 words per minute from clear copy.
Operate a variety of office equipment including a computer and assigned software.
Understand and follow oral and written directions.
Establish and maintain cooperative and effective working relationships with others.
Communicate effectively both verbally and in writing.
Complete work with many interruptions.
Meet schedules and time lines.
Receive, sort, screen and distribute mail.
Perform mathematic calculations with speed and accuracy.
Demonstrate interpersonal skills using tact, patience and courtesy.
Plan, coordinate and organize department or site activities and coordinate flow of communications and information for the administrator.
Assure efficient and timely program area operations.
Compose effective correspondence independently or from verbal instructions.
Perform a variety of clerical accounting duties in support of assigned department or program.
Compile, prepare, and verify comprehensive reports concerning a broad spectrum of subject matter.
Utilize a computer to input data, maintain automated records and generate computerized reports.
Work independently with little direction.
Learn, interpret, apply and explain laws, codes, rules, regulations, policies and procedures.
Understand and resolve issues, complaints or problems.
Work confidentially with discretion, and maintain confidential information regarding employer-employee relations.
Develop, advocate, and present management positions.
Plan, organize, prioritize, and schedule work for support staff.
Determine appropriate action within clearly defined guidelines.
Maintain regular and reliable attendance.

EDUCATION AND EXPERIENCE:

Any combination equivalent to: graduation from high school and four years increasingly responsible clerical or administrative assistant experience involving frequent public contact. Proven ability to maintain sensitive and confidential information.
